ON ELECTION DAY: THE POLLS will be open from 6:30 A.M. until 7:30 P.M. on the day of the PRIMARY ELECTIONS. All polling sites in the County will be open. All precincts have the same polling sites as of the last election, except for the Kings Mountain area, and Polkville Precinct and Bethware Precinct. Kings Mountain #1 and Kings Mountain #2 Precincts will be voting at the Kings Mountain YMCA, 211 N. Cleveland Avenue, and Kings Mountain #3 and Kings Mountain #4 Precincts will be voting at Mauney Memorial Library, 100 S. Piedmont Avenue. Polkville Precinct will be voting at Polkville Baptist Church Gymnasium, 4214 Polkville Road, Polkville, N.C. Bethware Precinct will be voting at Bethlehem Baptist Church, 1017 Bethlehem Road, Kings Mountain, N.C.
