PUBLIC HEARING

ECONOMIC DEVELOPMENT; KERNS TRUCKING INCENTIVE AGREEMENT

Kristin Fletcher, Executive Vice-President of Economic Development, presented an

incentive grant contract to Commissioners. Kerns Trucking will be relocating but maintaining their

business in Cleveland County and investing an additional \$150,000 in their existing business. The

company will be located at 703 S. Battleground Road, Kings Mountain. Ms. Fletcher shared details of

the agreement, some of which included:

- \$150,000 Investment
- Five year grant term
- Tax value at least \$861,810

Chairwoman Boggs opened the public hearing at 6:20 p.m. (*public notice was accomplished in accordance with the mandates of NCGS 158-7.1, with an advertisement published in* <u>*The Star</u> on September 24, 2009*)</u>

Michael Chrisawn, Cleveland County Chamber President, spoke in support of the project by stating the importance of keeping small business owners in business and keeping existing businesses in Cleveland County. He also thanked Mr. Kerns for his additional investment in Cleveland County.

Hearing no additional comments, Chairwoman Boggs closed the public hearing at 6:22 p.m.

Commissioner Hawkins has known the Kern's family for many years and stated that they are a very well respected family who have been involved in Kings Mountain for many years.

Commissioner Hutchins added, "This is what I have wanted to see, Commissioners partnering with small businesses to keep them in Cleveland County."

Commissioner Holbrook thanked Mr. Kerns for remaining in Cleveland County when he had the opportunity to go elsewhere.

NORTH CAROLINA BAPTIST MEN TRAINING CENTER

David Brown began by showing a brief video about a Baptist Men Training Center located in Red Springs, North Carolina. Mr. Brown is currently serving Elizabeth Church in their handyman ministry and understands that there are many in need in Cleveland County.

The Baptist Men Training Center will be located off of Lafayette Street behind Kates Skating Rink. Forty-three acres were purchased for this project. Twelve acres have been cleared and fenced in. Roads have been graveled and a metal building is currently under contract. The site could house approximately 200 people. Here, they could eat, shower and worship. Another building will be built for housing of building materials. The plans also call for a trailer park for those with campers or

trailers and a sports facility.

Mr. Brown said, "Instead of our residents going to other places for mission trips, people will

come to Shelby." Mr. Brown described the project as an economic development tool. Special events

including trainings and regional meetings will be held here. People will shop and visit restaurants while

in Cleveland County. This facility could also be used as for emergency housing and a staging area in case of disaster.

Harold Causby also spoke of the benefits of this project. He was then followed by Mayor of Shelby, Ted Alexander. He explained the positive effects this project will have on the community. Some of which include:

- An increased tax base as houses are re-habbed
- Community Development
- Economic Stimulus
- This project will complement the Weed & Seed Program and Project Safe Neighborhoods
- Stimulating local volunteerism
- Helping churches in mission

Mayor Alexander explained that the City of Shelby has helped in many ways with respect to street paving and utilities and have saved the Baptist Men approximately \$35,000 to date. Lastly, Keith Dixon with the Greater Cleveland County Baptist Association spoke. "We are excited about the work camp becoming a reality. No one entity in our county can meet the housing needs of our community. Many other counties wanted to be considered for this camp. This project will be here for the next fifteen to twenty years." Mr. Dixon closed by asking Commissioners to help with this effort. The total project cost will be approximately \$1.5 Million.

Commissioners thanked the Baptist Men for what they are doing and noted that they will possibly review this request at a worksession.

KINGS MOUNTAIN GATEWAY TRAILS

Shirley Brutko offered greetings from the Kings Mountain Chamber Office. She invited Commissioners to the Grand Opening of the Kings Mountain Gateway Trail on November 7, 2009. She thanked several companies and many individuals for their hard work on the project including Cleveland County Planning Director, Bill McCarter. She explained the purpose of the trail is for economic development, travel & tourism and a better quality of life for our citizens. She said, "There are no other projects like this in North Carolina mainly due to the fact that the trails are bikable."

The trail committee is busy putting together a 5K and a childrens run and are hoping to eventually tie in the trail with the triathalon.

DESTINATION CLEVELAND COUNTY UPDATE

Chairwoman Boggs introduced JT Scruggs to present an update on Destination Cleveland

County. Mr. Scruggs presented Commissioners with a handout titled "Destination Cleveland County Brief Timeline of Activities May 2009-October 2009" (*copy found on Page* ______ *of Minute Book 31*). He explained that the Museum Designers are in the process of putting together design for exhibits and they have been working on filming for exhibits including an interview with Steve Martin. A photo researcher has been in Cleveland County visiting the archives and taking pictures for possible exhibit design. Commissioner Hutchins asked JT Scruggs about the status of the elevator at the Historic Courthouse. Mr. Scruggs explained that the architect is looking at that now and hopes to have a design by the beginning of January. He said, "The architect is cautioning us to do one thing at a time so we do not have to fix anything at a later date."

<u>COMMISSIONER REPORTS</u>

Commissioner Hawkins:

The unveiling of the conference center will be held on October 28, 2009 at Cleveland Country Club. Commissioner Hawkins was very excited and proud of the partnerships that have made this possible.

The Health Department has received a grant for help with funding the free rabies clinics. At the most recent rabies/flu shot clinic, there were 750 rabies shots and 250 flu shots given.

The Humane Society and Animal Control have been working together regarding a plan for the adoption of animals that will go into effect on January 1, 2010.

The City of Shelby has advertised for bids for the construction of the new airport terminal.

Commissioner Hawkins asked that a sympathy letter be sent to the family of the late David Banks offering condolences from the County Commissioners.

Commissioner Accor:

Commissioner Accor commended the Department of Social Services for the work that they do and the many trials that they face. Serving on the DSS Board, Commissioner Accor sees first-hand the amount of work that they do for the citizens of Cleveland County. Commissioner Accor called her last two weeks, "very inspiring".

Commissioners discussed scheduling a worksession for October 28, 2009 at 2:30 p.m.

There being no further business to come before the Board at this time, Ronnie Hawkins made the motion, seconded by Mary Accor, and unanimously adopted by the Board, to adjourn. The next regular
