<u>EMERGENCY MEDICAL SERVICES: AMBULANCE & RESCUE FRANCHISE</u> <u>CONTRACTS</u>

County Manager David Dear presented Ambulance and Rescue Squad Franchise Contracts for review. He noted that all contracts are for one year and there have been no changes to the contracts since last approved.

<u>ACTION:</u> Mary Accor made the motion, seconded by Ronnie Hawkins, and unanimously adopted by the Board, to adopt the franchise agreements for Boiling Springs Rescue Squad, Grover Rescue Squad, Kings Mountain Rescue Squad, Shelby Rescue Squad and Upper Cleveland Rescue Squad. PUBLIC HEARING

PLANNING DEPARTMENT ZONING MAP AMENDMENT-DAVID HERNDON (Case #09-

<u>07)</u>

Mr. McCarter presented a petition from David Herndon for a large scale zoning map amendment.

The petition included rezoning 420 acres along Cleveland Avenue (NC226) from Residential (R) to

Restricted Residential (RR). The petitioners also requested to remove the Corridor Protection (CP)

overlay district from this area.

He provided background information as follows:

Existing Land Use: Residential single-family homes and one existing business.

Future Land Use: Residential.

Utilities: Public water provided by Cleveland County Sanitary District, no sewer.

Transportation: NC-226 considered a major thoroughfare.

Mr. McCarter also reviewed the following recommendations from the Planning Board and the

Planning Consultant:

Chuck Nance, Planning Consultant, Isothermal Planning and Development Commission: APPROVE

The existing land use is mostly residential, and the future land use is also projected as residential. It is our opinion that the County could rezone these properties from Residential to Restricted Residential and remove the CP Corridor Protection overlay.

David Morrow, Chairman, Cleveland County Planning Board: APPROVE/DENY

The Planning Board separated this case into two zoning issues:

Residential (R) to Restricted Residential (RR) – Approved by vote of 5-2.

Removal of the Corridor Protection District (CP) – Denied by vote of 6-1.

The Board also heard from property owners that did not wish to be included (Brackett & Edmondson).

The Board recommends that they be removed from the rezoning.

In 2005, NCGS 153A-341 was amended to require that planning board review include written comments on the consistency of each amendment with the Land Use Plan, and any other relevant plans. The Board must also explain why the action is "reasonable and in the public interest".

Consistent with the future Land Use Plan

Restricted Residential zoning is consistent with the current land use plan.

The Land Use Plan also calls for the removal of the CP overlay district throughout the county, and replaced with commercial nodes at strategic intersections.

Is the amendment reasonable and in the best interest of the public?

It is the desire of the petitioner to protect and enhance the property values in this area through more restrictive zoning.

Mr. McCarter noted that the Brackett Family and the Edmonson Family asked that their names be removed from the petition. Removal of these two properties would add up to approximately 50% of the property area. However, the percentage of participation is based on the number of property owners not the area of property. Mr. McCarter explained that the reason for the request to remove the Corridor Protection (CP) overlay district was to deter additional businesses from locating next to a residence.

Chairwoman Jo Boggs opened the public hearing at 6:35. (Notice of this hearing was accomplished in accordance with NCGS 153A-343, with legal ads published in the Star on October 24 and October 31, 2009.)

Jeff Scism, said that he was not notified by the county about the proposed re-zoning. Mr. Scism purchased the property in mid-July. He opposed the rezoning stating, "It is not good for Economic Development and it will hurt land development in the area."

Aaron Brackett, owns approximately 200 acres in this area and is opposed to the rezoning, "We need to keep options open for our children. They may not be able to build a house."

Boyd Edmonson, owns a business at 1134 Cleveland Avenue, spoke in opposition of the rezoning stating, "I am opposed to the change, leave it like it is."

Danny Brackett, spoke in opposition.

Darren Scism, explained that he recently purchased the property with his brother. Several lots were cut and the property value increased. He explained that the purchase of this property was an investment for him and the zoning change may hurt the value of the property.

Freida Lail, spoke in opposition of the project stating that she would like to "keep her option open."

David Herndon, introduced himself as the petitioner. Recently, Mr. Herndon had his property appraised. Due to the economic conditions, property values have decreased over the last year. Mr. Herndon explained that the purpose of this petition is to protect the property values. Mr. Herndon feared that keeping the CP District and allowing for additional businesses in this area would not "fit the mold" for the neighborhood. He also noted that the installation of mobile homes would hurt the property values. Mr. Herndon asked the audience for a show of hands from those in favor of the rezoning. Approximately eight hands were raised.

Seeing no others interested in speaking, Chairwoman Boggs asked Commissioners if they had any questions before she closed the public hearing.

Commissioner Hutchins reiterated that approximately nine property owners would like to be removed from the petition (*Clerks Note: not all of those opposed signed the original petition and several people represented one property*) Mr. McCarter explained that Commissioner could change the size of the rezoning to make it smaller and remove those properties in opposition, but they could not make it larger.

Commissioners discussed the possibility of denying the petition and requesting the property owners to re-petition.

Hearing no additional comments, Chairwoman Boggs closed the public hearing.

<u>ACTION:</u> Mary Accor made a motion to deny the removal of the Corridor Protection

Overlay District from this area and to approve the zoning map amendment excluding those properties in opposition of the amendment. The motion died of lack of a second.

<u>ACTION:</u> Ronnie Hawkins made the motion, seconded by Johnny Hutchins and unanimously adopted by the board, to deny the removal of the Corridor Protection Overlay District and to deny the zoning map amendment. (Commissioner Hawkins suggested that those in favor of the rezoning re-petition the Commissioners)

REGULAR AGENDA

<u>CLEVELAND COMMUNITY COLLEGE BOARD OF TRUSTEES</u>

Due to the passing of David Banks, Cleveland Community College is requesting that

Commissioners appoint one person to fill Mr. Banks unexpired term. Commissioners received letters

from Hoyt Bailey and Dr. Steve Thornburg recommending Jim Gold be appointed to this position.

Commissioner Hawkins, serving as the School Board representative on the Community College Board of

Trustees has worked with Mr. Gold in the past on the Board of Trustees and noted that he has done a

great job. He has attended the ethics training and the Board of Trustees training required to serve.

ACTION: Ronnie Hawkins made the motion, seconded by Johnny Hutchins, and unanimously adopted by the Board, to appoint Jim Gold to fill the unexpired term of the late David Banks to expire June, 2010 with the understanding that Mr. Gold must complete the required Commissioners Board Training. (Clerk's note: Commissioner Accor stated that she would like to abstain from voting. However, under NCGS 153A-44 [Duty to Vote] and Commission policy her failure to vote was recorded as an affirmative vote.)

ADJOURN

There being no further business to come before the Board at this time, Mary Accor made the motion, seconded Johnny Hutchins, and unanimously adopted by the Board, to adjourn. Next regular scheduled meeting will be held on *Tuesday, November 17, 2009 in the Commission Chamber*.
