PERSONNEL ORDINANCE REVISIONS

Alexis Pearson, Human Resources Director, presented several Personnel Ordinance Revisions to Commissioners for approval.

<u>ACTION:</u> Mary Accor made the motion, seconded by Ronnie Hawkins, and unanimously adopted by the Board to *approve the following Personnel Ordinance Revisions:*

Article VI. Leave of Absence

Section 12. Sick Leave

This section is to be amended by adding the following highlighted areas and defining immediate family member. Immediate family member is defined the same as under the Family Medical Leave Act for item (b) and (d) only.

Sick leave with pay is not a right which an employee may demand but a privilege granted by the Board of Commissioners. An employee may be granted sick leave if the absence is due to:

- (b) Medical/Dental appointments (for spouse, child or parent of employee)
- (d) Illness of a member of the employee's immediate family, (spouse, child or parent of employee) or exposure to a contagious disease when continuous work might jeopardize the health of others.

Bereavement

(e) Death in the employee's immediate family, not to exceed three (3) days, for any one occurrence. Additional leave time, (i.e. vacation, holiday or comp time) under exceptional circumstances, may be authorized by the Department Head. Immediate family for bereavement purposes is defined as wife, husband, mother, father, brother, sister, children, grandparents, grandchildren, plus the various combinations of half, step, in-law, and adopted relationships that can be derived from those named.

Article VI. Leave of Absence

Section 19 A. Leave Entitlements

Military Family Medical Leave Entitlements

Amendments to the FMLA by the National Defense Authorization Act (NDAA), January, 2008 expanded the FMLA to include new sections regarding special FMLA coverage for eligible families of U.S. military service members.

- e) Qualifying Exigency Leave An eligible employee is entitled to up to 12 weeks of leave for any qualifying exigency arising out of the fact that the spouse, son, daughter or parent of the employee is on active duty or has been notified of an impending deployment to a foreign country.
- f) Covered Service Member Leave An eligible employee who is the spouse, son, daughter, parent or next of kin (closest blood relative of a covered service member who is recovering from a serious illness or injury sustained in the line of active duty is entitled to up to 26 weeks of leave to care for the service member.

Article IV. Recruitment and Employment

Section 9. Probationary Period of Employment

This section to be amended by removing twenty four (24) months and adding nine (9) months. All other highlighted areas are to be added in full or deleted as indicated.

An employee appointed to a permanent position shall serve a probationary period of six (6) to twenty-four (24) months nine (9) months. In accordance with State Personnel Guidelines, employees who are "career state employees" will not retain permanent employment status until the satisfactory completion of twenty-four (24) months of service. Any employee serving a probationary period following initial appoint may be dismissed at any time during the probationary period if found to be performing assigned duties unsatisfactorily and will not have coverage under Article III, Grievance Procedures. The employee must be given notice of dismissal, including reasons. A permanent employee serving a probationary period following a promotion shall be demoted as provided in Section 11 of this Article if unable to perform assigned duties of the new job satisfactorily. Career state employees must serve a probationary period of not less than three months (3), nor more than nine months (9) as established by the director of the county SPA agency.

No employee shall remain on probation for more than nine (9) months, except in the case of employees who are employed as "career state employees" or are serving in a trainee appointment. Employees are required to successfully complete all educational and experience requirements before attaining permanent status. If the period of the trainee appointment equals or exceeds nine months, the employee must be given permanent status or be separated at the completion of the trainee period. Permanent appointments do not confer career status.

See Career Status Definitions (Addendum).

(b) Should have his/her probationary period extended (not to exceed nine 9 months). This extension does not apply to career state employees who are required to complete a twenty-four (24) month probationary period.

Article III. Pay Plan

Section 3. Administration of the Pay Plan

This section to be amended by removing half and changing to full step and adding ending at step 3.

- (b) Progression to the Standard Job Rate. Upon completion of one (1) year of satisfactory service, the employee will be elevated to the next half full step of the pay plan ending at step 3. Thereafter, each year upon completion of satisfactory service, the employee will be elevated to the next half-step until he/she reaches the Standard Job Rate (Step 4) of the assigned salary range.
- (c) Failure to Perform Satisfactorily. An employee failing to perform satisfactorily, whether during the probationary period or advancement from one salary level or half-step to the next salary level, will be denied his/her scheduled salary increase. Appropriate disciplinary action will be taken by the Department Head in accordance with Article VII of this Ordinance. Employees who have advanced to the Standard Job Rate (Step 4) will be required to perform at a level no less than satisfactory or will be subject to disciplinary action.

Appendix L. Employee Assistance Program (EAP)

This section to be amended by removing and adding the following highlighted areas.

3. Critical Incident Referral

Critical incidents are those situations in which employees are subjected to trauma in the line of duty. Examples include, but are not limited to a worker involved in a serious injury or the accidental death of a coworker. In such situations, management shall notify the EAP staff immediately, and give them the employee's names. who will in collaboration with management, develop an appropriate response. It will become the responsibility of the EAP staff to contact, inform, and counsel those employees. The EAP staff will notify management of the contact and follow up verbally and in writing.

<u>INVOLUNTARY ANNEXATION</u>

At a meeting earlier this year, Commissioners asked that a resolution be adopted stating their views on involuntary annexation. County Clerk, Kerri Melton, prepared a draft resolution for review by Commissioners. Commissioners shared their comments. Commissioner Hawkins voiced his opinion stating that he believes services should be provided before an area can be annexed. He also believes that residents along newly constructed utility lines should not be required to tap on. Commissioner Hutchins believes that a vote shall be taken and a majority of those residents in the proposed annexation area be in

agreement with the annexation before the area can be annexed. He also stated that, residents should not be expected to pay for the cost of running utility lines in newly annexed areas.

NUMBER 14-2010

RESOLUTION SUPPORTING LEGISLATION MODERNIZING ANNEXATION LAWS

WHEREAS, Cleveland County fully supports NCACC's Intergovernmental Relations goal regarding modernization of annexation laws; and

WHEREAS, the North Carolina General Statutes allow municipalities to annex properties meeting statutory standards without involvement of the affected property owners or the affected County; and

WHEREAS, residents under consideration for involuntary annexation are not allowed to vote on this issue nor do they have representation on the governing body making the final decision; and

WHEREAS, residents affected by involuntary annexation have no appeal process short of pursuing legal action through the court system; and

WHEREAS, Cleveland County strongly supports residents right to vote whether or not their property will be annexed; and

WHEREAS, Cleveland County supports requiring a direct provision of municipal water and sewer services to newly annexed areas; and

NOW, THEREFORE, BE IT RESOLVED, THAT, the Cleveland County Board of Commissioners expresses strong opposition to the current state laws allowing involuntary annexation, supports the requirement of a majority vote of residents in the proposed annexation area, supports no taxation of annexation area until services are provided and fully supports NCACC's efforts to modernize these annexation laws.

COMMISSIONER REPORTS

NCACC is currently in support of a Puppy Mill Bill. Commissioner Hawkins expressed his interest in this bill and his hope that NCACC will continue to support it. The bill has received criticism from Breeders. Margarite Mebane, Cleveland County Humane Society, has developed a food bank for animals. Due to the current economic conditions, pet owners are sometimes unable to feed their pets. This food bank will provide food for the animals of those in need.

Commissioner Accor shared the success of the second meeting of the Cleveland County Youth Council explaining that the children were willing to talk and developed the top ten issues for youth in Cleveland County.

Commissioners congratulated Commissioner Eddie Holbrook for receiving the Order of the Long Leaf Pine.

ADJOURN

There being no further business to come before the Board at this time, Mary Accor made the motion, seconded by Johnny Hutchins, and unanimously adopted by the Board, to adjourn the meeting.
