REGULAR AGENDA

PETITION TO ABANDON A PORTION OF HARBOR POINT DRIVE:

Commissioner Allen asked to recuse herself from the petition discussion

because of personal interest (it is her property). The board voted and unanimously approved her recusal. Chairman Falls then called Bill McCarter, planning director, to the stand. Mr. McCarter said that there is a right of way on Harbor Point Drive, located at 110 Harbor Point Drive and there is a petition for the county to abandon it. The commissioners are required to hold a public hearing and the commissioners are required to approve a resolution.

ACTION: Commissioner Hutchins made the motion to approve the resolution and to set the public hearing for June 16th, seconded by Commissioner Holbrook, and unanimously approved by the Board.

A RESOLUTION IN SUPPORT OF CONNECT NC: Chairman Falls called upon Henry Earle, to read the following resolution:

A Resolution in Support of CONNECT NC

Whereas Governor Pat McCrory unveiled the CONNECT NC bond proposals on April 17, 2015; and,

Whereas the CONNECT NC proposals will connect North Carolina cities and towns by building roads, upgrading technology and constructing education facilities; and,

Whereas the two proposal bonds of approximately \$3 billion will go before the legislature in the fall of 2015; and,

Whereas the transportation bond includes work on Highway 74 in Cleveland County and I-485 in Mecklenburg County; and,

Whereas Highway 74 and Interstate 85 are vital to the continued economic growth of Cleveland County;

NOW, THEREFORE, the Cleveland County Board of Commissioners do hereby resolve to support Governor Pat McCrory and his efforts to improve the infrastructure of North Carolina through the CONNECT NC initiative.

Commissioner Hutchins said this was a good thing and will improve the conditions on Highway 74 and Interstate 85, which are vital to our continued economic development.

ACTION: Commissioner Hutchins moved to approve the resolution, seconded by Commissioner Holbrook, and unanimously adopted the Board.

BUDGET PRESENTATION: Chairman Falls called County Manager Jeff Richardson to the stand for a budget presentation. The manager thanked the board for their strategic direction with the 2015-2016 budget. The manager covered the following topics:

• School funding: Natural growth from growing tax base, increase in sales tax revenue and capital allotment, amounts to an extra \$1 million

in school funding and students expected to be just over 15,000 next year.

- Economic Development: \$225K given to workforce development.

 With unemployment hovering at 6% it is imperative to show companies that the county is committed to creating an employment ready work force. There are 29 projects, with \$2.8 million in tax revenue this year.
- Public Safety: The county is budgeting \$90K for key card entrances in the administrative building, law enforcement center intercom and jail facility upgrades. The manager proposed \$125K in early holiday payout for employees that are required to work on holidays. They would be paid for the day then instead of cashing out their comp at a much later time. All volunteer fire districts will be funded at a full 5 cent rate.
- New Health Department: The new health department is on time and under budget and expected to open in February 2016.
- Community Education/Customer Service: \$60K for county
 marketing/rebranding, \$147K for the shooting range, \$200K grant
 received for a multi-purpose recycling program. \$150K for animal
 control office and program upgrades.

- Fiscal Sustainability: The county is quickly approaching the 18% capital reserve that the Commissioners set as a goal. \$75K in the budget for a facilities master plan that will dictate facilities planning for the next 5-10 years. \$100K to the community college capital fund. They are facing needs with aging facilities.
- Capital Projects: \$50K to the Shelby Airport, \$50K for Public Safety
 Radio Maintenance, \$100K DA office renovations, \$50K Sheriff's
 Evidence Room upgrades and \$350K for out year capital planning.
- Staffing: One IT administrator at the new health department, one human resources assistant to help with Workplace Wellness and two additional 911 operators for the midnight shift.
- Employee Compensation: 2.4% base ½ step increase for employees with over 1 year tenured experience, 3.0% one-time lump sum payout to all benefited employees. Extra 2.4% for all Sheriff's Office employees. \$35K for college tuition assistance program (CCC, GWU, and state schools), 400K for health insurance. Health Savings Account is moving from \$750/year to \$1000/year. The 70/30 split on insurance is moving up to 80/20.

Commissioner Hutchins thanked County Manager Richardson and the staff on such a fine budget. He's very proud of how well the county is doing.

Commissioner Allen reiterated it and said she appreciates the cost savings and is very happy about the compensation plan. Commissioner Hawkins said it is the best budget he has seen in a long time. He reiterated that being behind like they were is not something they want to do again.

Commissioner Holbrook said it's very evident that this budget is excellent and that the presentation was very visual and well done. Chairman Falls thanked the department heads for what they did in making the budget happen and for finding ways to save costs. He also thanked them for their loyalty.

ACTION: Commissioner Hawkins made the motion to set the public hearing for the budget to June 2^{nd} . It was seconded by Commissioner Holbrook and unanimously adopted by the board.

COMMISSIONER'S REPORTS:

Commissioner Hawkins: Attended the airport advisory board meeting but had most recently spent most of his time in Seattle so he didn't have much to report.

<u>Commissioner Allen:</u> Commissioner Allen said she has had a busy couple of weeks, met with the Buxton group regarding retail. She also attended Bill Hooker's 25 year anniversary at United Way and North Shelby's Hearts and Hooves awards banquet.

<u>Commissioner Hutchins:</u> Commissioner Hutchins said he had meetings with the MPO and gun range advisory board, looking to try to compete and get a GLOCK match for next spring.

<u>Commissioner Holbrook:</u> STEAG was excellent as was the legislative roundtable with the CEO program.

Commissioner Falls: Chairman Falls thanked the board and the staff for the budget.

ADJOURNMENT

Chairman Falls entertained a motion to adjourn the meeting. The motion was made by Commissioner Hutchins, seconded by Commissioner Hawkins and unanimously approved by the Board. The next regularly scheduled meeting will be on Tuesday, May 19, 2015 at 6:00 p.m. in the Commissioners Chambers.
